Overall objective: To support inclusive and sustainable development in Mongolia through promotion of quality employment focusing on the non-mining sector


#### **Component 1**

#### Component 2


Enable private sector job creation through targeted interventions to sustainably strengthen specific value chains where Mongolia has potential comparative advantages

**SPECIFIC ACTIVITIES Strengthen conditions** and capacity for private sector employment creation in specific value chains in livestock and vegetable sectors.




# Value Chain Innovation Platforms (VCIPs)

## **Target locations**




6 Provinces and Ulaanbaatar peri-urban area of Mongolia

#### **Meat Value Chain**




- Animal diseases limit export
- Poor animal health and breeding
- No traceability in meat sector
- Low quality of meat animals

- Lack of knowledge for n export requirements, international standards, GAP, GHP and hygiene,
- Poor formal market linkages



# **Dairy Value Chain**




- No cold chain between herder and processors
- Lack of feed and high feed cost
- Low quality and yield
- Limited accessibility of veterinary and breeding services
- Lack of market access

- Poor marketing
- Poor quality of raw milk
- Low sales volume and market visibility
- Low production in winter time



# Vegetable value chain



- High prices for seeds and limited variety
- Low price, low yield
- Shortage of working capital and few producer organizations
- Low capacity of storage and processing technology in local level

- Low consumption of vegetable
- No standards for vegetable grading, sorting and packaging of collection center.

#### Textile value chain

- Upgrading spinning and finishing process of wool and cashmere
- Building multi-skilled experts service
- Skills development using UNIDO Blended Training tool
- Business and market linkages

- Sustainable 'green' hides and skins quality improvement
  - Environmental standards LWG protocol
  - Quality assurance UNIDO Benchmarking
  - Cleaner tanning technology no chromium, hair save unhairing

- Skills and capacity development in leather industry
